If you are one of the 16 million self-employed professionals across the U.S., relief is right around the corner. You'll be happy to know that a government COVID relief program is still available and specific to your needs! You can claim the Qualified Sick & Family Paid Leave Wage Credit right now. The window for applications is expiring soon, so you need to act fast to take advantage of this life-changing credit.



WHO IS ELIGIBLE?

Though millions of self-employed individuals are eligible for the Self-Employed Tax Credit (SETC), **all three of the following key elements are needed** to qualify.

1. Self-employed individual



Did you receive a 1099 in 2020 or 2021 for the work you did?

Note: Many people have a 1099 side hustle or gig work with their W-2 wages. *See the list to the right and see who might be eligible for the SETC.*

2. Paid self-employment taxes



Did you have positive net earnings on your Schedule SE (included with your 1040 income taxes)? **Note:** Self-employed individuals who created an S-Corp will not have self-employment wages for those K-1 wages.

3. Individual was unable to work



Were you unable to work, including telework, due to COVID-19, being subject to quarantine orders, caring for an individual with COVID-19, or caring for a child whose school or childcare was unavailable due to COVID-19?

HOW MUCH IS AVAILABLE?

The total paid leave available is a result of two different government orders, the Families First Coronavirus Response Act (extended by the Consolidated Appropriations Act*) and the American Rescue Plan Act of 2021, taking into consideration the period between 4/1/2020 and 9/30/2021, which add up to a maximum total of 130 days of paid leave.

Depending on your situation, the combined provisions of these acts could add up to a maximum of \$32,220 per individual, distributed as a refund. **This credit is not a loan.**

Once you know your credit amount, it's just \$1,995 to complete the process. Eligible applicants will receive a check in the mail or direct deposit from the IRS corresponding to their credit amount.

WHO GETS A 1099?

There is an exhaustive list of self-employed individuals who receive a 1099 and are eligible to claim this credit.
